4. Matters arising

a. Keep Britain Tidy Campaign posters have arrived. Councillors discussed where these posters can be placed in the village. Clerk to arrange fitting of these throughout the village at various locations.

5. Correspondence

a. Estimate of Rough sleepers in Beeford between 2am and 6am on Thursday 22nd November 2018 has been conducted and there were no rough sleepers reported in the area. A nil return has been sent back to Simon Riley, Housing Strategy Officer.

b. Zurich Insurance renewal documents have been received for approval by the Council. The Clerk was successful in getting the premium reduced by £65.36p due to competitor interest. It was agreed that the Parish Council annual Insurance Policy to be renewed with Zurich Insurance.

c. Email received from Cllr Jane Evison regarding the Chairman bringing to the attention of the Council in the last meeting ERYCC and Hull City Council selling the Data Base of residents. Cllr Evison confirmed that there are two versions of the electoral register, 'full' and 'open'. **The open registers is there for anyone to buy.** During the annual canvass undertaken by ERYCC residents are given the option to opt out of the open register. Residents can also opt out at any time by contacting ERYCC via email or telephone. Also it should be added that the ERYCC request a fee for copies of the open register which is in line with National Legislation.

d. Email received from Adam Boon, Digital Services Officer, ERYCC regarding issues with Broadband speeds in the village. He has asked Councillors who are experiencing difficulties to pass on their details which will be passed to open reach to look into this matter.

9. Lissett Wind Farm

- a. Vice Chairman Turner to attend Panel Review meeting - Lissett Community Wind Farm Fund on Wednesday 16th January 2019.
- b. East Coast Community Fund - The Clerk has spoken to Matt Young, Chief Executive, Grantscape who has confirmed that the funding criteria is a 5km line inland from the Coast and therefore Beeford is out of the area for funding. If this should change in the future Grantscape will let us know.

10. Crime

- a. Chairman read out crime statistics for the last month showing that Beeford has been relatively low.

11. Clerk informed the Parish Councilors that a new Lap Top needs to be purchased as the old one is in need of updating/repair. It was agreed that the Clerk purchase a new Lap Top, suitable to the requirements of the Parish Council administration centre which will remain the property of the Parish Council.
