

## Minutes of the Beeford Parish Council Meeting

### **4. Matters arising**

**a.** The Chairman confirmed that the road works in Beeford are near completion stage with only completion of the works in Main Street remaining, this being due to the ongoing repair works in relation to the water leak which would appear is still unresolved. ERYCC to be contacted in relation to this matter.

**b.** The Chairman confirmed that unfortunately there will be no Christmas lights at the Community Centre this Christmas this being due to an email which has been received from the Beeford Community Association stating the event will not go ahead and will be reviewed for Christmas 2020. Cllr Adamson thanked Cllr Wilburn for his time given in relation to the offer of tree lights. It was initially agreed that the Parish Council would contribute £250 towards the event (minuted 14/10/19 - 5c) however this will now be subject to a review by the Parish Council upon formal confirmation that this event will go ahead in 2020. The Chairman also commented that this was a huge disappointment and felt that the Community Centre Committee had missed an opportunity to unite the residents of Beeford by cancelling the event despite offers of support and sponsorship from both the Parish Council and the Londis store in Beeford.

**c.** The Chairman and Cllr Alan Turner attended the Meet the Commission meeting dated 7<sup>th</sup> November 2019 with both reporting back that the PCC Keith Hunter gave a presentation which included confirmation that since his appointment the Humberside Police Force has increased their officers from 1460 to 1900 with a further increase due within 2020.

In relation to Hornsea School it was raised by several Councillors of their concerns regarding the disruptive actions of several pupils who attend Hornsea School whilst waiting for the school bus @ Manor Drive which could ultimately result in either damage to the Shelter and injury to the pupils concerned. These concerns have already been raised with Hornsea School however it was felt that along with the contribution the Parish Council should reiterate these concerns to the Headmaster.
